Notice is hereby given that the Cleburne County Board of Education, 141 Davenport Drive, Heflin, Alabama on May 28th at 11:00 a.m. will receive publicly, competitive sealed bids in accordance with the State Bid Law.

Bids must be sealed with the words "RHS Bleacher Replacement Bid 07-2025 -11:00 a.m. May 28, 2025" plainly marked on envelope. All bids must be submitted to the Cleburne County Board of Education at 141 Davenport Drive, Heflin, AL 36264 on or before said date and time.

Proposals should be submitted according to specifications attached. Please contact Eli Hightower at eli.hightower@cleburneschools.net with any questions or to schedule a site visit.

Alabama laws require that, as a condition for the award of a contract by a school board to a business entity or employer with one or more employees working in Alabama, the business entity or employer must provide documentation of enrollment in the E-Verify program. During the performance of the contract, the business entity or employer shall participate in the E-Verify program and shall verify every employee that is required to be verified according to the applicable federal rules and regulations. The contractor's E-Verify Memorandum of Understanding must be included with the bid. If you do not believe these requirements are applicable to your entity, include an explanation justifying such exemption. An entity can obtain the E-Verify Memorandum of Understanding upon completion in the E-Verify enrollment process located at the federal web site www.uscis.gov/everify. The Alabama Department of Homeland Security (http://immigration.alabama.gov) has also established an E-Verify employer agent account for any business entity or employer with the required documentation of enrollment in the E-Verify program. An Employer Identification Number (EIN), also known as a Federal Tax Identification Number, is required to enroll in E-Verify or to establish an E-Verify employer agent account.

Act No. 2012-491 now requires school boards to include the following clause in all contracts or agreements: "By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the state of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom."

§ 39-2-4, Ala. Code 1975 - All bidders shall file with his or her bid either a bid bond or cashier's check for an amount not less than 5% of the awarding authorities estimated cost or of the contractor's bid, not to exceed \$10k • Any cashier's checks must be drawn on an Alabama bank
